2. Under the Single Stage, Single Envelope Procedure, Bidders are required to submit sealed envelopes, both Technical Bid and the Price Bid, enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security amounting to a minimum NRs. 85,000 which shall be valid for 30 days beyond the validity period of the bid.
