4. Electronic bids must be submitted to the Chhatreshwori Rural Municipality, Salyan, by PPMO's e-GP system www.bolpatra.gov.np/egp on or before 12 hours on 2076/02/02. Bids received after this deadline will be rejected.
5. The bid will be opened in the presence of Bidders' representatives who choose to attend **at 1:00 hours** on 2076/02/02 at the **office of** Chhatreshwori Rural Municipality, **Salyan**. Bids must be valid for a period of **90 days** after bid opening and must be accompanied by a bid security, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid.
6. Under the single stage two envelope procedures bidders are required to submit simultaneously two separate sealed envelopes, one containing i) the technical bid and other ii) price bid, Both in turn enclosed in a one sealed envelope as per provision of ITB 21 of the bidding documents.
6. **Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non-responsive.**
7. If the last date of purchasing and/or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
