4. Pre-bid meeting shall be held at Chhatreshwori Rural Municipality, Salyan at **12:00 hours on 2075/2/05**
5. Sealed bids must be submitted to the Chhatreshwori Rural Municipality, Salyan, by hand/courier on or before **12:00 hours on 2075/2/14**. Bids received after this deadline will be rejected.
6. The bidswill be opened in the presence of Bidders' representatives who choose to attend **at 2:00 hours on 2075/2/14** at the **office of** Chhatreshwori Rural Municipality, **Salyan**. Bids must be valid for a period of **45 days** after bid opening and must be accompanied by a bid security, amounting to a minimum of as stated in above table, which shall be valid for 30 days beyond the validity period of the bid (i.e. 2075/4/28)
7. Bidders are required to specify the total price of the Bid in the Letter of Bid or the Bid Price in the Bill of Quantities. Failure to specify the total price of the Bid in the Letter of Bid or the Bill of Quantities shall be ground for declaring the bid non-responsive.
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
