The Government of Nepal [GoN] has allocated funds towards the cost of shankhamula park and intends to apply part of the funds to cover eligible payments under the Contract for shankhamula park (Contract No: CRM-WNB-2/75/76). Bidding is open to all eligible bidders as per Section V of Bidding Document

2. Chhatreshwori Rural Municipality invites electronic bids from eligible bidders for the construction of park with shankha and shiva parbhathi statue . under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: 7167470.55
Minimum Work experience of similar size and nature: 5

3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.

4. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of Chhatreshwori Rural Municipality, Bhotechaur, Salyan, Nepal or may visit PPMO e-GP system www.bolpatra.gov.np/egp.

5. A complete set of Bidding Documents may be purchased from the office Chhatreshwori Rural Municipality, Bhotechaur, Salyan, Nepal by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate, and upon payment of a non-refundable fee of 3000.0 NRs. till 02-05-2019 12:00 during office hours.

Bidder who chooses to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Project's Rajaswa (revenue) account as specified below

7. Sealed or electronic bids must be submitted to the office Chhatreshwori Rural Municipality, Bhotechaur, Salyan, Nepal by hand/courier or through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 02-05-2019 12:00. Bids received after this deadline will be rejected.
8. The bids will be opened in the presence of Bidders' representatives who choose to attend at 02-05-2019 13:00 hours at the office of Chhatreshwori Rural Municipality

Nepal. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 286700 which shall be valid for 30 days beyond the validity period of the bid.
9. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
10. Evaluation and Qualification Criteria:

General Construction Experience:

Experience under construction contracts in the role of contractor, subcontractor, or management contractor for at least the last (1)....5. years prior to the applications submission deadline.

For Single Entity : Must meet requirement

For joint Venture : Each Partner Must meet requirement. All partner combined and one partner not applicable.

(5) Construction cash flow requirement for a number of months (to the nearest half-month), determined as the total time needed by the Employer to pay a contractor's invoice, allowing for (a) the actual time consumed for construction, from the beginning of the month invoiced, (b) the time needed by the Project Manager to issue the monthly payment certificate, (c) the time needed by the Employer to pay the amount certified, and (d) a contingency period of one month to allow for unforeseen delays. The total period should not exceed six months. The assessment of the monthly amount should be based on a straight-line projection of the estimated cash flow requirement over the particular contract period, neglecting the effect of any advance payment and retention monies, but including contingency allowances in the estimated contract cost.
